The Digital Development Department of the World Bank Group is working with the Ministry of Finance(MoF), the Ministry of Innovation and Technology (MIT) and the newly created Ethiopian Communications Regulatory Authority (ECRA) of the Federal Democratic Republic of Ethiopia to provide a program of ICT Sector Reform and Support, 2018-2020.
